Nomination of an Asset of Community Value

Your nomination of an Asset of Community Value must meet the requirements of the Localism Act 2011 and the Assets of Community Value (England) Regulations 2012.

You must include information which explains and supports the reason why you consider the asset is of community value, and your organisation must meet the eligibility criteria.

Successful nominations will result in the asset being included in the published Register of Assets of Community Value.

Use of the Asset

You need to show that:

(i) The asset is currently being used for the benefit of the local community, and it is realistic to think it can continue to do so (section 88(1)), or

(ii) There has been a time in the recent past when an actual use of the asset benefitted the local community and it is realistic to think that there is a time in the next five years when it can do so again (section 88(2)).

Types of Organisation

The Localism Act section 89 and The Assets of Community Value (England) Regulations 2012 (Regulation 5) list the types of organisations and groups considered eligible to nominate assets of community value. These are:

- Parish Councils
- Neighbourhood Forums
- Unincorporated bodies
- Registered Charities
- Companies Limited by Guarantee
- Industrial and Provident Societies
- Community Interest Companies.

Local Connection

An organisation other than a Parish Council must demonstrate a local connection as defined by The Assets of Community Value (England) Regulations 2012 (Regulation 4)
