

## REQUEST 17396

I am submitting this request under the Freedom of Information Act 2000. I would be grateful if you could provide the following information regarding domiciliary care, supported living, and complex care services within your local authority for the period: - **Financial years 2023 and 2024:** 

- 1. Contact details (name, job title, email, and phone number) for managers or commissioning leads responsible for domiciliary care, supported living, and complex care services. If available, please also include contact details for managers linked to specific service user types, such as:
  - a) Children and young people.
  - b) Adults with physical or learning disabilities.
  - c) Mental health service users.
  - d) Substance misuse or addiction recovery.
  - e) Autism and ADHD.
  - f) Forensic or ex-offender support.
  - g) Complex care needs (e.g., ventilated patients, PEG feeding, spinal injuries).
  - h) Dementia care.
  - i) Palliative or end-of-life care.
  - j) Hospital discharge and reablement services.
- 2. An explanation of the process for becoming an approved provider of domiciliary care, supported living, or complex care services. Please include details of any frameworks or approved provider lists, selection criteria, renewal timelines, and whether you accept spot purchasing outside frameworks. If so, what percentage of contracts are awarded to spot providers and why?
- 3. Data on current and projected demand for each service user type above, including referrals made, unmet needs or shortages, geographic areas with high demand, and future forecasts (3–5 years).

Due to the implementation of the '2023 Procurement Act', which is anticipated to be in place by February 2025 (date is subject to change), the Procurement Team have not yet released information on any future procurement or renewal of current frameworks, however these will be under the new regulations.

Current contract timelines:

- a. Homecare services for Adult Social Care Contracted till March 2027 (option to extend 2yrs)
- b. Supported Living services for Adults Contracted till Nov 2026 (option to extend 2yrs)

We have minimal reliance on spot contracts outside of our contracted provision.

3. We are unable to detail by type stated by the requester as we do not use these types, however, we have provided a breakdown using our own Primary Support Reasons.

It is projected that our 65+ population will increase by 20% over the next 5 years.

- 5. The 24/25 framework hourly fee rates are £21.24 for domiciliary care, £20.10 for supported living wake support and £9.04 for supported living sleep support. These rates also cover more complex care where complexity of need is reflected in the volume of support hours. Rates for more bespoke specialist care are agreed with providers on an individual basis. Exempt rents £35.37-£400.
