- 1. I would like to request the number of a) breaches and b) re-negotiations of Section 106 planning obligations (as laid out in the Town and Country Planning Act 1990) in this local authority from the beginning of 2010 to the present day, or as recent as the data goes. This can be in either a yearly or quarterly format.
- 2. I would like also data on how many of these a) breaches and b) renegotiations referred to affordable housing obligations in the same time period.
- 3. I would also like data on how many enforcements of planning obligations this local authority carried out in the same time period.

RESPONSE

Q1 and Q3) Since 2010 there have been no breaches of Section 106 Agreements other than where a payment has been delayed. These instances have been dealt with in line with the Councils debt recovery policy which can be viewed online at the below link:

This process enables the Council to fully recover any sums due.

Q2. Re-negotiations have been through the use of a deed of variation (DoV) or supplemental agreement (SA). A list of DoV'ss and SA's signed between 1st January 2010 and 25th July 2024 has been provided with this response.

The way in which the information is recorded doesn't not enable us to identify the type of adjustment that has been agreed, this is outlined within each DoV or SA and will require cross referencing with the original agreements, the latter which are available to view online on the Council's website within the documentation associated with the parent planning application:

It is to be noted that the use of a DoV or SA does not necessarily mean they contain re-negotiated Section 106 planning obligations. For example, changes can relate to format, ownership, definitions or as a result of a reserved matters application on the back of an outline and supplementary agreements may be where one deeds binds an additional deed, includes the need for additional documents for homeownership schemes for example.
