PLATT FOLD ROAD LEIGH - EXPERIMENTAL RESTRICTION OF WAITING / NO LOADING / UNLOADING / PROHIBITION OF WAITING

NOTICE OF MAKING

NOTICE IS HEREBY GIVEN that Wigan Borough Council, in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984, Traffic Management Act 2004, of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, has made the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 150) which will come into operation on 29/09/2024 for a period of 18 months.

The effect of the Order is to introduce restricted waiting on the following lengths of road between the times and on the days specified below.

The effect of the Order is to introduce prohibited waiting on the following lengths of road at any time:

- Redwater Leigh both sides its junction with Platt Fold Road to 10 metres west of its junction with Platt Fold Road
- Platt Fold Road Leigh West side from 10 metres north of its junction with Redwater to 10 metres south of its junction with Redwater

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.

NOTICE IS HEREBY FURTHER GIVEN Wigan Borough Council will be considering in due course whether the provisions of the Order should be continued in force indefinitely. Any person may within the period of six months from the coming into force of this Order object to the making of the Order for the purposes of such indefinite continuation. Any such objections to the Order must be made in writing and specify the grounds thereof and must be made to the Assistant Director - Legal, Town Hall, Library Street, Wigan quoting reference RD/LS/DC/C108.1066 not later than 12/03/2025.
