SCHOLES / WARRINGTON LANE/ MILLGATE / SCHOOL LANE WIGAN – RESTRICTION OF WAITING / PROHIBITION OF WAITING / PROHIBITION OF LOADING

NOTICE OF PROPOSALS

NOTICE IS HEREBY GIVEN that Wigan Borough Council, in exercise of the powers under Section 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984, proposes to make the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 187) Order 2024

The effect of the Order will be to revoke restricted waiting at the following times and days:

| Road | Side | From | To | Period of Operation |

| Millgate, Wigan | Northwest | A point 113 metres southwest of its junction with School Lane | Its junction with School Lane | On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm |
| Millgate, Wigan | Southeast | A point 109 metres southwest of its junction with Warrington Lane | Its junction with Warrington Lane | On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm |

The effect of the Order will be to introduce restricted waiting on the following times and days:

| Road | Side | From | To | Period of Operation |

| Millgate, Wigan | Northwest | A point 113 metres southwest of its junction with School Lane | A point 25 metres west of its junction with School Lane | On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm |
| Millgate, Wigan | Southeast | A point 109 metres southwest of its junction with Warrington Lane | A point 25 metres west of its junction with Warrington Lane | On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm |

The effect of the Order will be to introduce prohibited waiting at any time on the following roads:

- Millgate, Wigan – both sides from its junction with School Lane to a point 25 metres west of its junction with School Lane

There will be limited exceptions permitting vehicles to wait to enable people to board or alight; for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers; for local authority, Water Companies and Post Office purposes; if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles) or in connection with a funeral; to take on fuel, water or air at any garage; for the delivery or collection of goods and for loading or unloading; or the avoidance of an accident.

The effect of the Order will be to introduce prohibited loading at any time on the following roads:

- Scholes, Wigan – both sides from its junction with School Lane to a point 25 metres east of its junction with School Lane
- Warrington Lane, Wigan – both sides from its junction with Scholes to a point 25 metres south of its junction with Scholes
- Millgate Wigan – both sides from its junction with Warrington Lane to a point 25 metres west of its junction with Warrington Lane
- School Lane Wigan – both sides from its junction with Millgate to a point 15 metres north of its junction with Millgate.

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.
